Eligibility Requirements

Registration:

Individuals must actively hold a USSF referee registration with PA-West and be in good standing meeting all requirements to be eligible for assignments.

Timeline:

Individuals must be actively registered and in good standing at the time of application/approval for a subsidy, as well as during the event, evaluation, etc. for which the subsidy is for, as well as at the point of the subsidy being paid out afterwards to the individual.

Effective Date:

All items are effective 11/1/2024 or later. If a later date is noted, then that date will supersede the effective date above for the handbook and that specific policy, procedure or subsidy.

Approval:

All individuals and events must be re-approved at the time of application, by either the State Referee Administrator (SRA) or State Director of Assessment (SDA). Failure to gain re-approval of an event, subsidy and eligibility, may nullify the individual from gaining said subsidy and support. The SDA and SRA have sole discretion to remove, add or adjust the event list, program structure, eligibility and requirements, as well as subsidy amounts to meet the needs of the development and advancement of referees in PA West.

Evaluation Subsidies

Effective Date: 1/1/2025 – 6/30/2025

Guidance: For PA-West Referees who are requesting an evaluation for a referee mentor, coach or national referee coach via OMS, for either development, maintenance or upgrade, this fee policy will apply. This structure will remain in place for the 6-month window stated above until 7/1/2025, where the new policy below will become effective.

***Unless a specific amount is set by US Soccer, or a higher amount was agreed to by the SRA and/or SDA for a coach.*

Effective Date: 7/1/2025

Guidance: For PA-West Referees who are requesting an evaluation for a referee mentor, coach or national referee coach via OMS, for either development, maintenance or upgrade, this fee policy will apply. This structure will remain in place beginning on 7/1/2025, until a new policy is created, or this policy is edited.

Payment

Requirements:

- Gain approval for the specific event, and confirm eligibility with the SDA
 - o Full information including your availability needs to be sent, so you may obtain written approval
- Attend the entire event, and provide confirmation (game assignments) to the SDA
 - o If you cannot attend the entire event, this may impact your eligibility for the stipend, or result in your receiving a partial stipend at the SDA's discretion
- Submit a pay voucher to the PA West State Office
 - o The SDA will need to approve the voucher, and may submit this on your behalf at times
- Payment will be issued within 8 weeks of receiving the pay voucher and the appropriate tax documentation
 - o For issues or concerns here please contact the SDA
